



21st Century Community Learning Centers (21st CCLC) and ESSER II Out-of-School Time (E2 OST) GPRA Data Collection and Reporting FAQs 2021-2022

What is GPRA and what is the reason for reporting?

The U.S. Department of Education (USDE) requires that State Education Agencies annually report on new GPRA measures in the 21APR Data Collection System in 2021-2022. It is important to show Congress the impact of 21st CCLC programs across Colorado. To show the impact and ensure continued funding of this valuable program, we have to collect and share data points that Congress has identified.

What are the GPRA measures for 2021-2022?

As a reminder, the USDE requires annual reports on the five new GPRA measures for 2021-22. To show the impact and ensure continued funding of 21st CCLC programs in Colorado, we must collect and share data by center and by grant on the following measures:

1. Academic Achievement
2. School Day Attendance
3. Grade Point Average (GPA)
4. Student Behavior
5. Student Engagement

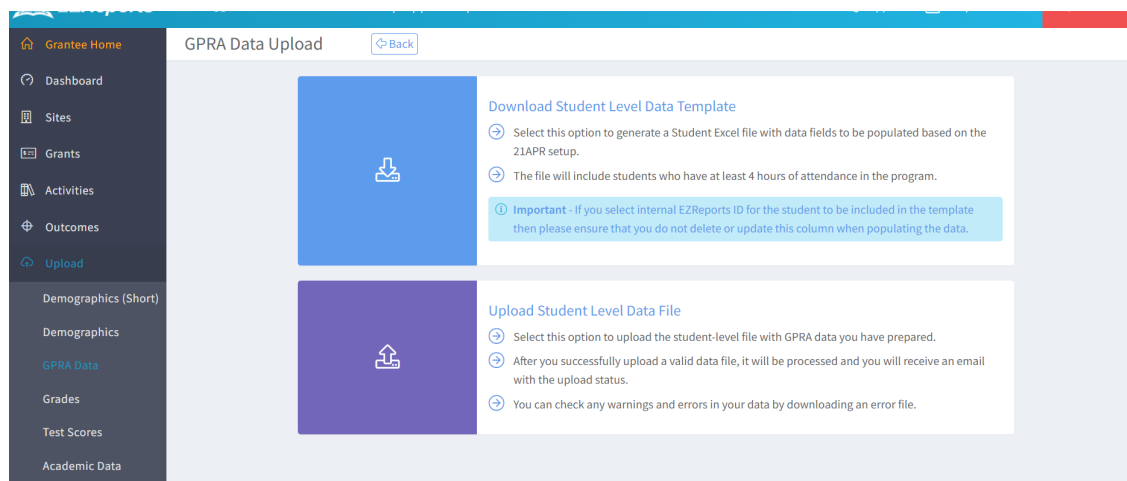

Which subgrantees report on the five GPRA measures?

Only 21st CCLC subgrantees in Cohorts VIII and IX need to report on the five GPRA measures. Subgrantees in the ESSER II OST (E2 OST) cohort do not need to report on the five GPRA measures, but need to submit Teacher Surveys only.

For which GPRA measures do 21st CCLC subgrantees have to submit their own data?

All 21st CCLC subgrantees must collect and submit data for GPA (#3), Student Behavior (#4), and Student Engagement (#5) using EZReports. See below for a screenshot on where to go to upload GPA (#3) and Student Behavior (#4) GPRA measures on the Grantee level.





What do grantees need to submit for GPRA Measure #1 (Academic Achievement) and #2 (Student Attendance)?

The program should collect State Assigned Student Identifier Numbers (SASIDs) for each participating student and submit them on EZReports. SASIDs are required for all programs for both GPRA and state evaluation purposes. We'll use SASIDs at the state level to gather data for Measure #1 and #2.

The Grade Point Average measure requires data from only students in grades 7-8 and grades 10-12. Do we need to collect GPA if we serve only elementary students?

No, you would not be required to submit GPA if you do not serve the students specified in this measure. You would leave these fields blank on the GPRA data upload.

How do GPA conversions work?

Subgrantees should pull source data from the district of their recipient school(s) if possible. If grades are for term/semester only, take the average across all terms/semesters. The method of conversion is at the discretion of the subgrantee, but we encourage the subgrantee to document the process for determining GPA and keep it consistent for the three-year grant period. Please refer to this table for other GPA conversions:

Letter Grade	Word Grade	Percentage Grade	GPA
A	Exceeding Expectations	90-100%	4.0
B	Above Expectations	80-89%	3.0
C	At Expectations	70-79%	2.0

Who is considered a regular attendee?

Students who have attended 75 hours or more of programming during the entire program year are considered regular participants for state reporting purposes. The 2021-22 program year started on July 1, 2021. 2021-2022 is a transitional year for data reporting so program hours accumulated in June 2022 will be counted towards the 2021-2022 school year. Program hours accumulated in July and August 2022 will be counted towards the 2022-2023 school year.

Do regular attendees have Teacher Surveys?

Students who have attended 45 hours or more of programming during the school year (September-May) should have a teacher survey for federal reporting purposes. These hours can help build toward regular attendee status for statewide evaluation purposes. Students who have attended summer programming but not the school year would not receive a teacher survey.

How is the EZReports data system set up?

To align with new federal reporting windows as well as the federal and state fiscal years, **the current 2021-22 EZReports system will now be active until June 30, 2022.** All subgrantees who will have summer programming in June 2022 will build their summer sessions and activities, add staff to their activities, register students and family members, and track attendance in the 2021-22 EZReports system.



All subgrantees who are planning summer programming in July and August 2022 will set up these programs in the 2022-23 EZReports system. Summer 2022 data from July 1, 2022 and on will be entered within the new 2022-23 school year system which will be made available on Monday, June 13, 2022.

How are grade levels considered in the 2021-22 and 2022-23 EZReports systems?

In the current 2021-22 system, your student grade levels will remain the same as your 2021-22 school year. However, in the new school year system, your student's grade level will be updated to the next grade level. Subgrantees do not change grade levels, as this is automatically done in EZReports.

What data do E2 OST subgrantees need to report?

E2 OST subgrantees do not need to submit data for the GPRA measures but still must complete Teacher Surveys in EZReports by June 15, 2022 to report on Student Engagement for statewide evaluation purposes.
