## **Summary**

Blueprint Schools Network is a non-profit management organization that supports schools in implementing a turnaround plan focused on five key areas: Excellence in Leadership, Daily Tutoring, Increased Instructional Time, Culture of High Expectations and Data to Improve Instruction. Blueprint has the capacity to serve as a full management partner or provide targeted services to a school. Blueprint works collaboratively with districts to build district capacity to manage turnaround schools. Blueprint also runs an intensive math tutoring program called the Math Fellows. The Math Fellows Program can support schools in implementing rigorous 1:1 daily tutoring for students.

In Colorado, Blueprint has previously worked with Denver Public Schools and Lake County Schools in Leadville, CO. They are willing to work in districts all over the state.
