Summary of 2019 Updates

Program Updates: WestEd is currently serving two schools in Aurora and one in Adams 14 with professional development focused on research-based teaching practices. Job-embedded coaching is provided as a follow up for teachers who receive training. Coaching is also available around other topics such as building capacity in school leaders to observe and debrief classroom instruction, as well as lesson planning.

Evidence Updates: Though WestEd's work in Colorado is too new to have an evidence base, it does provide evidence of school improvement in other schools it has worked with (in New York and California), including schools being released from receivership. WestEd currently self-assesses as having a Tier 4 evidence base for its work.
