Updates:

<u>Competitive Procurement:</u> Staff reviewed state policy and best practice with the Office of the State Architect and will add dollar thresholds to the FY25 BEST application/agreement to clarify when and how professional services and construction services must be competitively procured. BEST also provides written process for procurement. This will be revised accordingly as time allows.

Draft Language:

In alignment with the State of Colorado Office of the State Architect Policies and Procedures (SBP-BSC and SBP-SCP).

Professional Services:

- Professional Services fees estimated to be less than or equal to \$25,000 are considered discretionary and do not require a competitive bid or a Request for Qualification.
- Fees estimated to be between \$25,000 and \$100,000 grantee must contact/interview at least three (3) firms and select the most qualified. Public notification (advertising) is not required.
- Fees estimated to be greater than \$100,000 require both a public notification (advertising) and a Request for Qualification. Minimum solicitation time is 15 days and may include publication by electronic access or in a newspaper of general circulation.

*If grantee desires the option to carry forward an agreement beyond the scope solicited in a single category above (i.e. a master planning with the option to continue to design phase work), the project team must use the appropriate solicitation process based on estimated dollar values. Alternatively, the grantee may advertise separate Request for Qualifications for Bids for additional phases of work.

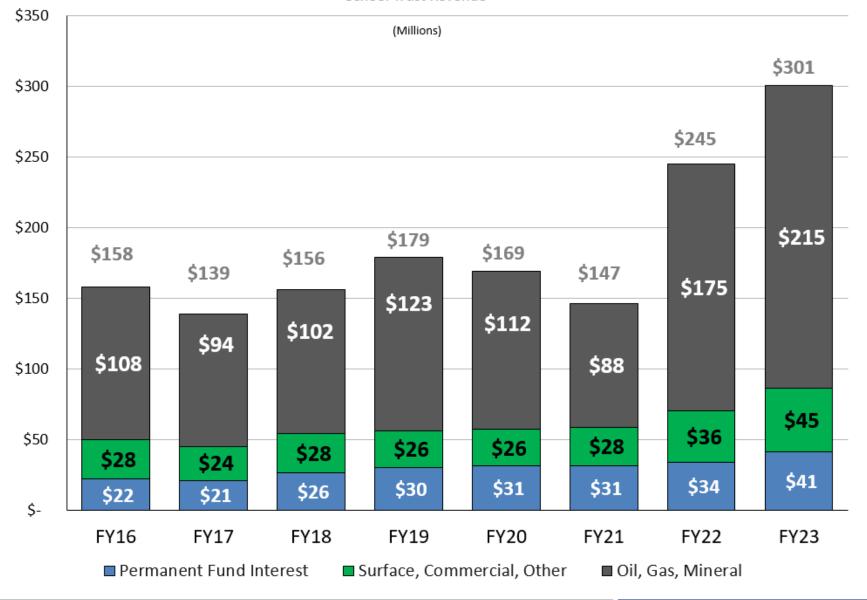








School Trust Revenue





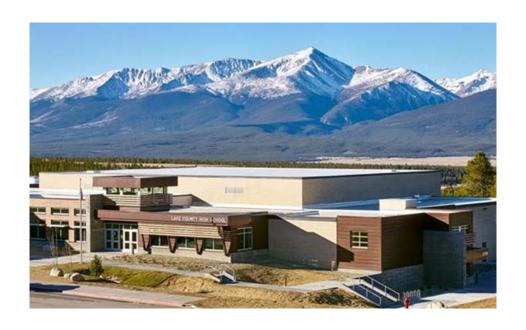

HB22-1146 Working Group Recommendation

#2: Impact Investing The legislature should consider allowing for opportunities to pursue impact investing related to the Land Board and permanent fund.

- 1. The Land Board and the Public School Fund Investment Board (PSFIB) should create mission statements that encourage investments to be made for the intergenerational benefit of the public education of school children;
- The Land Board and the PSFIB should explore education impact investment opportunities within the State School Lands Trust and the Public School Fund.



Working Group Discussion

"Investing the fund in ways that positively impact Coloradans dramatically amplifies the benefit the 'Trust' is providing. Instead of focusing on the 4% of the fund value that might be distributed each year, focusing instead on the 96% of the fund that is invested could be a game changer for Colorado kids."

"A mission statement for the permanent fund's investment strategy should include impact investment provisions that acknowledge the opportunity to help address major social issues impacting Colorado while also seeking financial returns. The treasurer and the [PSFIB] should build out an impact investment strategy in order to identify impact goals, performance goals, identify metrics to measure the impact of the fund's investments, risk management, etc."

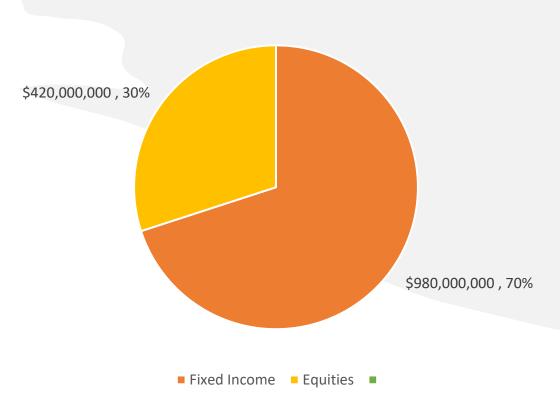
Changes to limitations on the overall investment portfolio of the permanent fund could be necessary in conjunction with a successful impact investment strategy in order to allow for future growth of the fund corpus and a balanced investment approach.

The Opportunity

Investing the PSPF in Colorado communities while still earning returns comparable to current investments, is a unique opportunity to significantly amply benefit while still optimizing return.

Current Asset Allocation

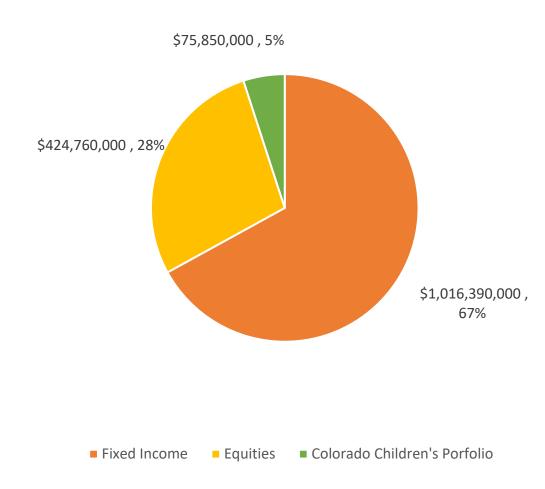

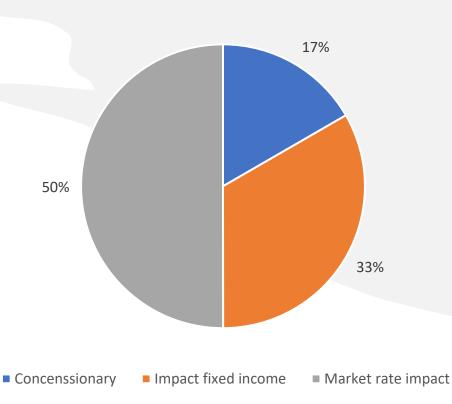

BACKGROUND:

The Capital Construction Assistance Board (CCAB) a rule change at the November 17, 2022 CCAB meeting to establish a process by which staff award grants to backup projects in an attempt to award all appropriated funds available each fiscal year.

22-43.7-109(7)(a) states that... "The board may recommend that any specific project only receive financial assistance if another higher priority project or group of projects becomes ineligible for financial assistance due to the inability of an applicant to raise required matching moneys by a deadline prescribed by the board as a condition of a financial assistance award for the higher priority project or group of projects."

Dear FY24 BEST Grant Applicant,

As Election Day, November 7, 2023, approaches we'd like to outline for you the process for finalizing BEST grant awards for bond-contingent and backup projects so that we can all prepare for a quick process to award all remaining funds for this grant round. With approximately \$9 million remaining from the FY24 BEST grant round and \$10 million from SB23-220, we currently have just under \$19 million available to award.

If you have been awarded a BEST grant but your match is bond dependent, we ask that you notify our office of the results as soon as your county clerk has posted official results. November 21, 2023, is the deadline to notify CDE, per the Financial Policies and Procedures Handbook. After November 21, at the latest, we will begin making grant award offers to backup projects.

Our process is as follows:

- BEST will offer any remaining funds from the FY24 grant appropriation to the highest ranked backup project.
- We ask that you respond within five business days, in writing, to confirm that you either accept or decline the offer.
 - o The remaining amount available may be less than what was requested in the grant application. Regardless of the amount of the award, you are required to complete the entire project as submitted in your grant application and approved by the Capital Construction Assistance Board (CCAB) and State Board of Education.
 - Accepting the offer is an acknowledgement that you have appropriated and allocated the full amount of matching funds and are able to start your project immediately. You may be asked to provide proof of this.
- If you need more time to officially accept the offer, please let us know immediately, as we may need to ask the CCAB for an extension of time.
- If you must decline the offer, the CCAB will deem the applicant to have withdrawn solely for the purpose of allowing the next-highest priority alternate project to be funded.
- At that point, we will make an offer to the next project on the backup list and continue down the list in an attempt to award all funds available.

1 CCR 303-3, Rules 6.3 & 6.4

- 6.3. Additional actions the Board may take when reviewing an Application:
 - 6.3.1. The Board may modify the amount of Financial Assistance requested or modify the amount of Matching Moneys required; and
 - 6.3.2. The Board may recommend funding a Project in its entirety or recommend a partial award to the Project;
 - 6.3.2.1. If a Project is partially funded a written explanation will be provided.
 - 6.3.2.2. If the Board recommends partial funding for a Project and the Applicant declines such funding, the Board will deem the Applicant to have withdrawn its Application.
- 6.4. The Board shall submit to the State Board the prioritized list of Projects.
 - 6.4.1. The prioritized list shall include the Board's recommendation to the State Board as to the amount of Financial Assistance to be provided to each Applicant approved by the Board to receive funding and whether the assistance should be in the form of a BEST Cash Grant, BEST Lease-purchase Funding or a BEST Emergency Grant.
 - 6.4.2. When funding State Board-approved alternate Projects, the Board may offer funding to a Project in its entirety or may offer a partial award, based on available appropriations. If the Board offers partial funding to a Project and the Applicant declines such funding, the Board will deem the Applicant to have withdrawn solely for purposes of allowing the next-highest priority alternate Projects to be funded.

Building Excellent Schools Today

Capital Construction Assistance Board Responsibilities



CRS 22-43.7-106, 109, and 110

- The function of the board is to protect the health and safety of students, teachers, and other persons using public school facilities and maximize student achievement by ensuring that the condition and capacity of public school facilities are sufficient to provide a safe and uncrowded environment that is conducive to students' learning.
- In performing its function, the board shall ensure the most equitable, efficient, and effective use of state revenues dedicated to provide financial assistance for capital construction projects pursuant to the provisions of this article by assessing public school capital construction needs throughout the state and providing expert recommendations based on objective criteria to the state board regarding the appropriate prioritization and allocation of such financial assistance.





- 1. To establish public school facility construction guidelines.

 Developed by staff. Reviewed/approved by CCAB. Mostly utilizes best practices by reference.
- 2. To conduct or contract for a financial assistance priority assessment. Facility Insight Program.
- 3. To review financial assistance applications and submit a prioritized list of projects (with an amount and type of financial assistance) to the state board. Request preliminary review of any or all applications from the division or any department, agency, or institution of state government with expertise or experience in construction management.

 All staff and CCAB work leading up to May Meeting. Many evaluation criteria are defined in statute.
- 4. To establish guidelines for assisting applicants in preparing applications.

 Staff regular work to support applicants in preparing applications (trainings, website, in-person visits).
- 5. To assist applicants in implementing projects through (but not limited to) the preparation of requests for bids or proposals, contract negotiations, contract implementation, and project and construction management.

 Staff regular work to support completion of projects.
- 6. To assist applicants in implementing energy-efficient public school facility design and construction practices.

 Developed by staff. Rule directs applicants to follow the Office of the State Architect's High-Performance Certification Program.





7. To authorize the State Treasurer to enter into lease-purchase agreements and to enter into sublease-purchase agreements on behalf of the state.

Legal and administrative steps to engage in lease-purchase financing.

- 8. To promulgate such rules as are necessary but not limited to:
 - 1. Conflict of interest rules for board members.
 - 2. Rules establishing evaluation criteria for matching moneys requirement waivers.
 - 3. Rules establishing the means by which awarded projects are publicly identified.

Rules are reviewed and revised on a regular basis.

9. The board shall establish an annual financial assistance timeline.

Developed by staff. Reviewed/approved by CCAB.





10. To review and award emergency financial assistance to an applicant at any time.

Separate application process from annual BEST grants.

- 11. Taking into consideration Facility Insight Assessment data, prioritize applications based on the following criteria (consider the condition of the entire public school facility for which the project is proposed and determine whether it would be more fiscally prudent to replace the entire facility than to provide financial assistance for the renovation project).:
 - 1. Projects that address safety hazards or health concerns, concerns related to facility security, and projects designed to incorporate technology in the educational environment.
 - 2. Overcrowding in public school facilities, including but not limited to projects that will allow students to move from temporary instructional facilities into permanent facilities.
 - 3. Projects that will provide career and technical education capital construction in facilities.
 - 4. Projects that assist public schools to replace prohibited American Indian Mascots as required by section 22-1-133.
 - 5. All other projects.

Priorities outlined in statute. Staff develop Facility Insight Assessment Data for board use.
