

2023-2024 Special Education End-of-Year Snapshot

Purpose:

The purpose of the Special Education End-of-Year Snapshot is to obtain data on students who were referred, evaluated, and/or received special education services at any point during the reporting period.

Dependencies:

- Student has been assigned a SASID and/or a LASID.
- Student has a record in the Special Education Participation file.
- Student has a record in the Special Education Child file.
- Students who are part of a district will have records in the Student Interchange.
 - A student within a district's jurisdiction will have a record in the Student Demographic file.
 - A student within a district's jurisdiction will have a record in the Student School Association file.
 - LASID should match the district/Student Interchange LASID.

Criteria:

For a record to be added to the Special Education EOY Snapshot it must:

- be included in both the Child and Participation Files
- contain a matching SASID and/or LASID in both the Child and Participation Files
- be error free in both the Child and Participation Files

*All records that meet the above criteria will be pulled into the snapshot **EXCEPT** those with a PAI code of 23, 24, 31, or 32 or a Special Education Part C Referral code of 00.

Notes:

- The Student Interchange is the primary source for SASID, LASID, Student's First Name, Student's Middle Name, Student's Last Name, Gender, Date of Birth, Ethnicity, Race, and Grade Level.
- If the record is not submitted in the Student Interchange, the demographic fields listed above will be pulled from the Special Education IEP Interchange.
- The Special Education Child, Participation, and Student Interchange files will be joined based on the following criteria: SASID, LASID, School Year, Admin Unit (or district), and error free records.
- Data pulled from the Student Profile Interchange will be the non-tagged data.

Note: The primary key for the Special Education End of Year Snapshot aligns with the primary key for the IEP Interchange and Student Interchange.

FEDERAL RACE STUDENT

Federal Race/Ethnicity Reporting Category - the single category used to classify the student or staff member in aggregated federal or state reporting such as pupil counts, graduation rates, and assessment results. This designation is based on the race and ethnicity information provided to the reporting district by the student (or his or her parent/guardian) or staff member.

- Default to '00'
- If ETHNICITY_STUDENT = '1' then set STUDENT_FEDERAL_RACE = '04'
- If ETHNICITY_STUDENT = '0' then set STUDENT_FEDERAL_RACE = '07' where more than one of the following fields = '1'
 - RACE_INDIAN_STUDENT
 - RACE_ASIAN_STUDENT
 - RACE_BLACK_STUDENT
 - RACE_WHITE_STUDENT
 - RACE_HAWAIIAN_STUDENT
- If ETHNICITY_STUDENT = '0' and only one of the following fields = '1', use the below logic to set STUDENT_FEDERAL_RACE
 - If RACE_INDIAN_STUDENT = '1' then STUDENT_FEDERAL_RACE = '01'
 - If RACE_ASIAN_STUDENT = '1' then STUDENT_FEDERAL_RACE = '02'
 - If RACE_BLACK_STUDENT = '1' then STUDENT_FEDERAL_RACE = '03'
 - If RACE_WHITE_STUDENT = '1' then STUDENT_FEDERAL_RACE = '05'
 - If RACE_HAWAIIAN_STUDENT = '1' then STUDENT_FEDERAL_RACE = '06'
