

2024-2025 Student Discipline Snapshot File Layout

Purpose:

The purpose of the Student Discipline Snapshot is to obtain discipline, restraint, and seclusion data on all students during the reporting school year.

Dependencies:

Students have been assigned a SASID and updated in the RITS system. Students have a record in the Discipline Action Interchange file.

Students have a record in the Student Demographics Interchange file and the Student School Association Interchange file.

Criteria:

Pull all error-free records from the Discipline Action file joining data from the student interchange files.

Notes:

The records selected will be joined with data from the Student Interchange- Demographic and Student School Association Files.

For joining Student Demographic, use District Code, School Year, and SASID.

For joining the Student School Association, use District Code, School Code, School Year, and SASID where Date of Discipline >= Entry Date and <= Exit Withdraw Date (or Exit Date is null).

Student's Federal Race/Ethnicity

The single category used to classify the student or staff member in aggregated federal or state reporting such as pupil counts, graduation rates, and assessment results. This designation is based on the race and ethnicity information provided to the reporting district by the student (or their parent/guardian) or staff member. For the method used for determining the federal race/ethnicity code reported, reference the PowerPoint document '<u>How Collected Race and Ethnicity Information will be Reported</u>'.

Multilingual Learner Y/N (formerly English Learner)

The English Learner (ELL) status for the student record. If the student's Language Background is not 'Eng' and Language Proficiency = 1, 2, 6, or 7 (NEP, LEP, FEP Monitor Year 1, or FEP Monitor Year 2) then the ELL status is '1' (Yes). Students with Language Proficiency = 0, 4, 5, 8, 9 (N/A, PHLOTE, FELL, FEP Exit Year 1, or FEP Exit Year 2) are indicated as '0' (No).
