#### Current Discipline Projects

#### HB 23-1291: Procedures For Expulsion Hearing Officers

• Legislation passed in 2023 updated requirements for the expulsion hearing process and requires a new training for individuals who are acting as Expulsion Hearing Officers, starting in January 2025

#### SB 23-029: Disproportionate Discipline in Public Schools

• CDE will be supporting the facilitation of a task force during the 2023-24 school year. The task force will be studying disproportionate discipline, CDE's processes for data collection and sharing of resources, and can make administrative or legislative recommendations

#### HB 22-1376: Supportive Learning Environments for K-12 Students

• CDE will begin publishing district profile reports that cover data points related to learning environments including attendance, behavior, discipline, and other measures



# SB 23-029: Disproportionate Discipline in Public Schools





# To study and make recommendation regarding school district discipline policies and practices, state and local discipline reporting requirements, and local engagement.



#### **Discipline Task Force Duties**

- Define "disproportionate discipline" with considerations for size, location, and demographics of the local education provider
- Review CDE's plan and progress in standardizing discipline data
- Review CDE's plan for creating district profile reports
- Determine whether CDE's plan and progress in standardizing discipline data should include reports of alternative disciplinary measures taken prior to a student's suspension or expulsion
- Recommend processes and provide resources for public engagement in a local school district board of education's discussions of discipline data
- Review existing public engagement processes
- Review best practices identified by the department concerning dropout prevention and student re-engagement
- Identify alternative approaches to discipline and address concerns around workforce and other resource shortages in school districts in relation to school discipline practices and reporting
- Recommend legislative and administrative changes and analyze the costs and time frames required to implement the changes

## **Colorado Open Meeting Laws & Legislation**





- The Colorado Open Meetings Law (OML) generally requires any state or local governmental body to discuss public business or to take formal action in meetings that are open to the public. The Colorado Open Records Act (CORA) allows members of the public to access the records of state and local governments, unless specific exceptions apply.
- Under the OML, legislatively created task forces meet the definition of a "state public body" and are therefore subject to the law's requirement that "all meetings of two or more members of any state public body at which public business is discussed or at which any formal action may be taken are declared to be public meetings open to the public at all times." C.R.S. 24-6-402(2)(a).

#### Meeting Minutes & Colorado Open Records Act (CORA)

- Minutes of any meeting of a state public body must be recorded (through written notes or an audio/video recording) and open to public inspection.
- The Department of Education will treat all records of a legislatively created task force as public records and therefore subject to CORA. This means that written records (including electronic documents, handwritten notes, emails, text messages, etc.), videos or audio recordings that are related to the task force and maintained by the Department will be available to the public upon request.

**Chairperson Responsibilities:** The Chairperson will manage the activities of the members of the task force for the purpose of achieving the mandates outlined in SB 23-029, including but not limited to scheduling and planning Task Force meetings; setting agendas; presiding over meetings, aided by Task Force facilitators and CDE staff; maintaining order and ensuring public engagement, as needed; and performing other duties determined by the Task Force. *Estimated additional time commitment: 1-2 hours per meeting* 



**Co-Chairperson:** The Co-chairperson will serves in the absence of the Chairperson, and performs additional duties, including but not limited to supporting the planning of meetings, setting of agendas, and engagement of the public, as needed.*Estimated additional time commitment: 1-2 hours per meeting* 





## Process & Expectation Discussion





### Shared understanding about meeting norms and participation

- Cameras on whenever possible; mute when not speaking; use chat and 'raising hand' emoji's
- Prioritize inclusivity & input from all members
- Assume positive intent; listen to understand
- Prioritize engagement & active participation; regular attendance at Task Force meetings
- Decision-making process
  - Voting & required quorum (poll)

### Process for virtual meetings and the inclusion of task force members and the public

- Meetings will alternate between in-person and virtual formats
- In-person meetings include a virtual participation option?
- How should public participation in meetings be structured? Public comment period?





Shared understanding about timeline, in-person and virtual meeting schedule

- Virtual meetings will be two hours; In person meetings will be 5.5 hours
- Task Force must conduct at least 8 meetings between Oct. 15, 2023 and June 30, 2024; approximately 2 meetings per month
- Draft report due by May 15; Final report due by June 30, 2024
- Do we want to create a predictable, bi-weekly schedule (i.e. every-other-Tuesday)?



### Process for identifying and engaging with stakeholders and content experts, as needed

- Dedicated discussion time at each meeting? What role do TF members want to play in creating agendas?
- How do we identify and bring additional stakeholders (beyond TF members) into the conversation?





- Process for creating and vetting recommendations
  - Identification of recommendations resulting from each meeting - standing agenda item
  - Identification of draft recommendations by April 15; circulate for member input & review, identify potential gaps in information needed.
  - Comprehensive set of initial recommendations to be prepared for inclusion in May 15 draft report.
