

Data Review for August - a snapshot

Avg Monthly Attendance	Avg Total Days in Session	Total Unique Students Served
90%	16	957
% Excused of Total Absences	% of Unexcused of Total Absences	Avg Approx # of Seats
81%	19%	22

Takeaways:

- 1. The range of average monthly attendance was between **71% and 100%**
- 2. Approximately **50% of Facility Schools** had fewer than 20 days in session for the month of August
- 3. Approx 1/3 of Facility Schools serve exactly the number of students they have seats for, 1/3 serve an average of 4 additional students then they have capacity for and 1/3 serve and average of 23 additional students

(2) Medicaid Reimbursement Funds

SB23-219 Requires the department of Health Care Policy and Financing (HCPF) and the work group to consult - to recommend a plan to provide guidance to approved facility schools on the eligibility standards required to request and receive medicaid reimbursement funding for therapeutic services to reduce reliance on school district revenue for therapeutic services.

HCPF deadline for recommendations November 1, 2023

(3) Specialized Day Schools - Continuum expansion



Specialized Day Schools - created for a specialized student need & educational niche

- Education setting with CDE credentialed staff School only
- Authorized by CDE then approved by OFS monitored by OFS will be accredited by SBE

Senate Bill: (5.5) "SPECIALIZED DAY SCHOOL" MEANS A SCHOOL THAT SERVES STUDENTS WHO ARE REFERRED TO OR PLACED BY A PUBLIC ENTITY OR PLACED IN A SPECIALIZED DAY SCHOOL BY A HOSPITAL, HEALTH-CARE PROVIDER, BEHAVIORAL HEALTH PROVIDER, CASE MANAGEMENT SERVICE, COURT, DIVISION OF YOUTH SERVICES, SCHOOL DISTRICT, COUNTY DEPARTMENT OF HUMAN OR SOCIAL SERVICES, OR OTHER STATE AGENCY BECAUSE THE STUDENTS' BEHAVIORAL AND EDUCATIONAL NEEDS ARE BEYOND THE CAPACITY OF THE STUDENTS' CURRENT EDUCATIONAL PLACEMENT DUE TO THE SEVERITY OF THE STUDENTS' NEEDS OR THE REQUIREMENT FOR HIGHLY SPECIALIZED PROGRAMMING.

Day Treatment Centers

Day Treatment DOES NOT = School

CDHS licenses all eligible facilities - these sites:

- May or may not have educational programs
- May or may not have CDE licensed teachers
- Are not overseen by CDE/ Office of Facility Schools
- Must provide treatment
- May choose to apply to become Approved Facility Schools or not

CDE Approved Facility Schools -

- Are schools that reside within residential or stand alone day treatment programs/buildings
- Are schools that students attend with CDE licensed teachers and must also participate in treatment components
- Are monitored by both CDHS (clinical) and CDE (education)
- Approved Facility Schools housed in day treatment facilities will continue as a part of the continuum



Differences between Day Treatment and Specialized Day Schools

Day Treatment	Specialized Day Schools
Licensed by CDHS	Authorized by CDE
Monitored by CDHS (clinical) and CDE (education)	Monitored by CDE
Treatment - psycho-social and behavioral treatment by clinical credentialed staff is required	School/education setting only, CDE licensed education staff providing highly specialized educational programming
May be placed by 8 different placing agencies	Majority of placements will most likely come from school districts
Opportunity to house an approved facility school	Will be approved facility schools

Specialized Day Schools Must -

As proposed in rule, to become an authorized Specialized Day School, the items below are required by CDE:

- Proof of successful health, fire, and safety inspections
- City and county zoning approval to operate
- Employee background checks (FBI, CBI, and registered sex offender)
- A written policy for tracking and reporting incidents
- All education staff CDE licensed
- A site visit by CDE will occur prior to authorization

(4) Rule-making in progress...

Schedule of now through December/January:

- Notice of Rulemaking Hearing will occur this afternoon
- Rulemaking Hearing in December
- Finalization and implementation in January, 2024



Rulemaking Authority

- Granted by Colorado General Assembly, per C.R.S. 22-2-406 and 22-2-407
- "The facility schools board shall promulgate rules in accordance with the State Administrative Procedure Act, article 4 of title 24, C.R.S."

(5) What about multi-site Facility School Growth?

STRATEGIC THINKING QUESTIONS for Work Group Dialogue:

- 1. Are the existing multi site corporations set up to successfully operate with only 1 or 2 special education directors?
- 1. Is fully funding the baseline model for multi site corporations enough of an incentive? Or are their additional needs that need to be addressed?
- 1. What needs to be true (beyond money) that can better support multi site corporations?

Medicaid Coverage Basics

Medicaid cannot cover the cost of educational services that are the responsibility of the school either under FAP or IDEA

Current Barriers?

- Somethings we have heard:
 - Consent for treatment of minors
 - Knowing Medicaid eligibility
 - Confusion on what services are the responsibility of the school and what can be covered by Medicaid
 - Availability of qualified personnel (e.g. therapists, other specialized clinicians)
 - Understanding the role of Regional Accountable Entities
