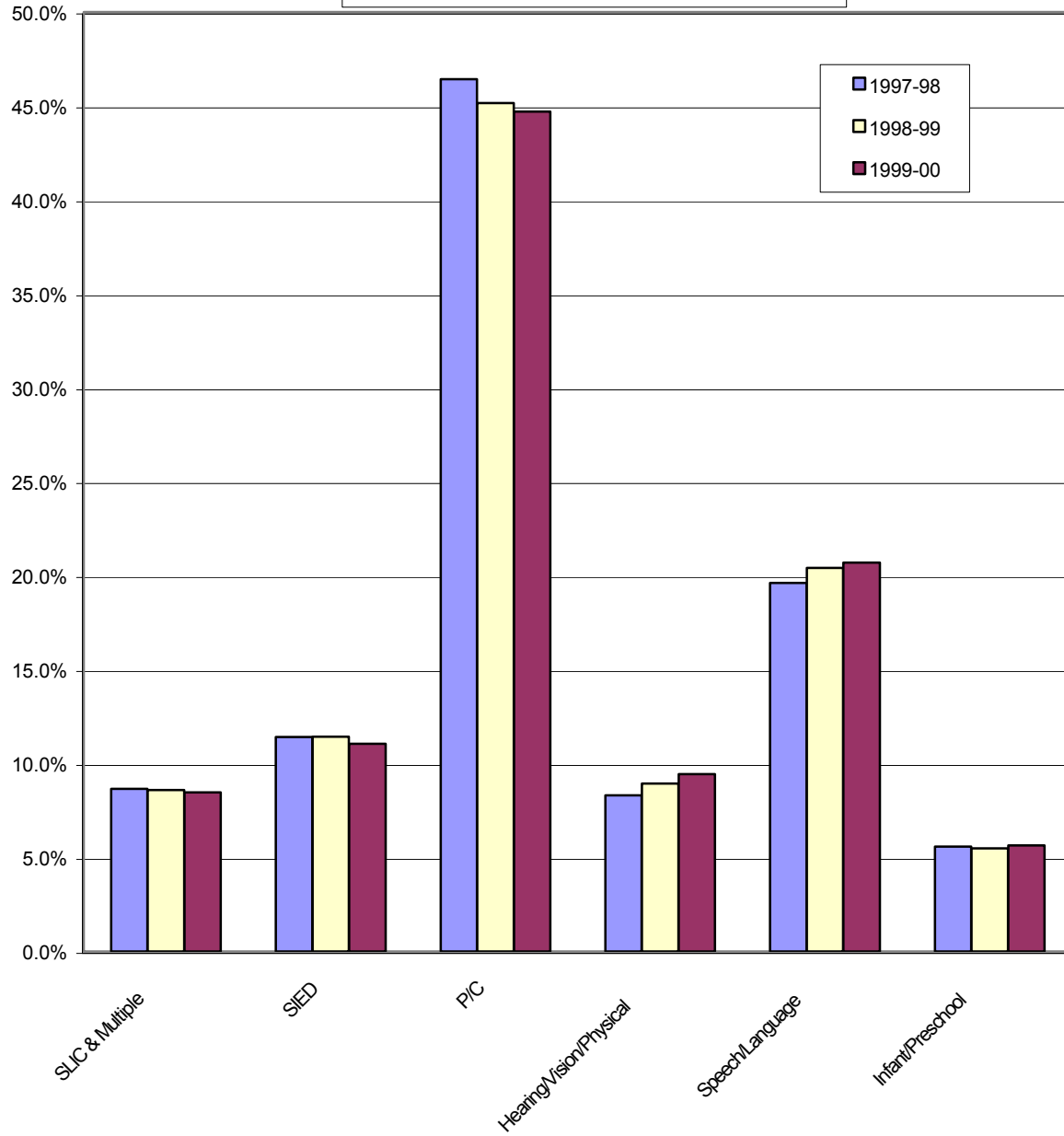

- The percentage of special education students in each age group is consistent from year-to-year. The largest percentage (44 percent) is in the 6-11, or elementary age group. Twenty-four percent of the students are ages 12 through 14.
- Within the 6-11 age group, 43 percent are identified with perceptual/communicative disabilities, and 30 percent are speech/language. As the ages of the students increase, fewer students are identified with speech/language disabilities, and more are identified with emotional disabilities.

Percent of Ethnicity, by Disability**

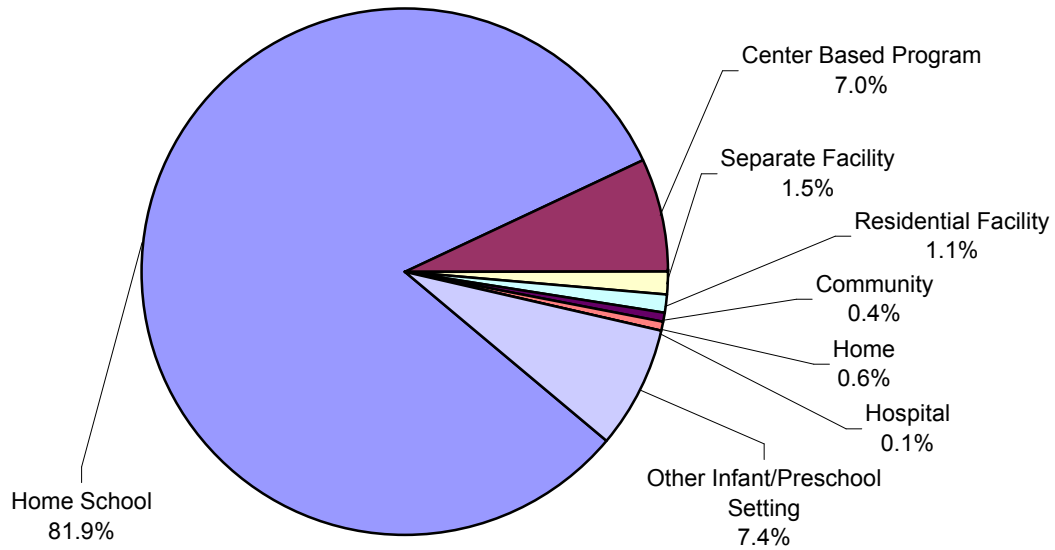

- The percentage of students served in the general classroom with support has decreased from 37.8 percent in 1997-98 to 33.6 percent in 1999-00.
- The number of students in residential facilities continues to increase.

1999-00**

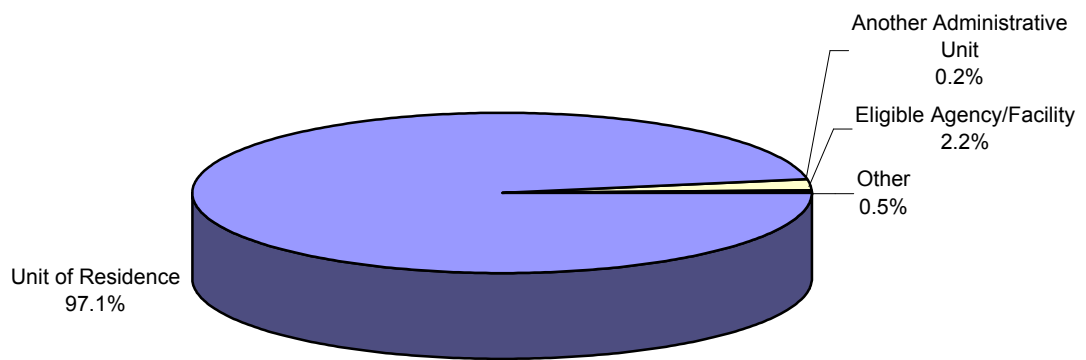

- The administrative unit K-12 special education teachers that were unqualified for their assignment increased from 15.0 to 17.2 percent. This includes staff on TTEs, as well as those with no Colorado teaching license, and those teaching out of their endorsement area.
- In 1999-00, the percentage of unqualified staff in State operated programs (25.6 percent) and eligible facilities (24.2%) was much higher than the percentage in administrative units.

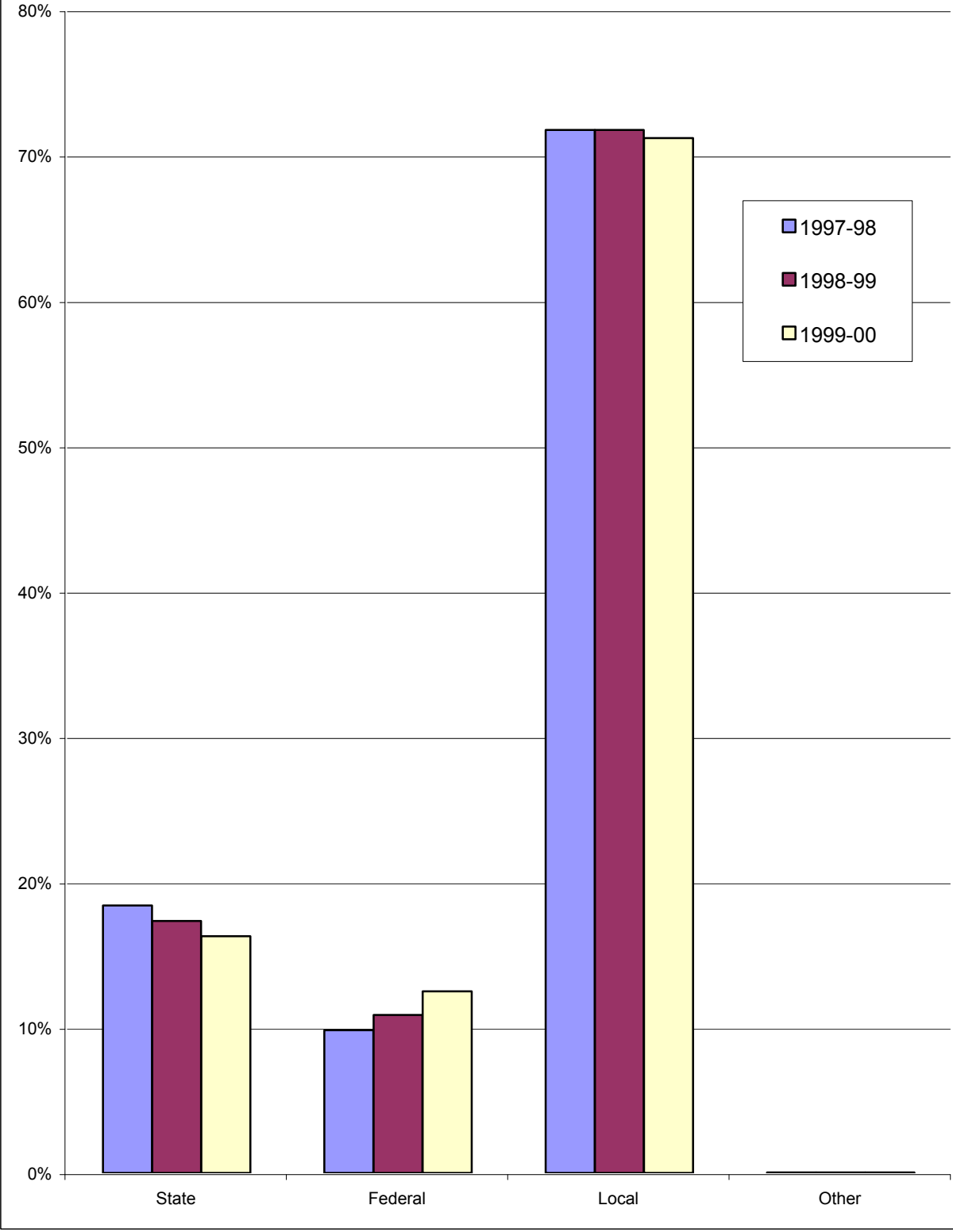
