# PROMISING PRACTICES

Growing Together Family Day, sponsored by the San Juan BOCES, is an event that promotes a time for individuals with disabilities and their parents and families to network, gather information on topics of interest, and learn about community and school resources.

The event started with a welcome and keynote entitled Growing Up and Growing Strong- Living with a Disability. Participants then chose from a wide array of informational and interactive 45-minute sessions. Session breakout topics included:

- Get Present! The Science and Application of Mindfulness Awareness in Parenting
- The Pitfalls and Victories of Advocating for Youth
- Financial Planning for the Future
- Happy Graduation! Now What?
- Self-Advocacy 101

The majority of participants requested having even more breakout session options in the future. Parents left the family day empowered to advocate for their children in school and beyond.

### RESEARCH BRIEF

Preparing, recruiting, and sustaining membership of accountability committees can be a very difficult task. It is particularly important to build capacity of family members who step into leadership roles on School or District Accountability Committees.

In August 2016, the Anne E. Casey foundation developed a planning tool for "Engaging Parents, Developing Leaders." This toolkit is based on a literature review, one-on-one interviews with over 40 leaders in the field, and three parent focus groups.

The research indicated four domains that represent "building the organizational capacity needed to better serve parents." The four domains are:

- Build a culture of respect, inclusion, and equity.
- Coach parents on their competence and confidence in their roles.
- Listen to and collaborate with parents.
- Work with other organizations and communities to benefits parents.

The tool contains self-assessments and planning documents to best satisfy the four domains.

### SACPIE SPOTLIGHT

In addition to focusing on family partnerships in P-12 education, FSCP practices and the study of FSCP within higher education has proven to be an asset *for students attending colleges* and *for faculty who prepare educators*. The Institutions of Higher Education (IHE) SACPIE sub-committee has collected and/or created materials to support thinking about (a) the bonds of college students with their families and (b) effective approaches to instruction of FSCP content within college programming.

A) Family engagement in college can lead to multiple benefits. In the 2015 ASHE Higher Education Report, it states, "There is evidence that parental/familial support is significantly associated with college students' developmental, academic, and social/emotional outcomes" (p. 38).
