- February 3, 2023 Meeting Minutes – **Approved**
- Free Lunch For All – CDE anticipates this will be at the March 24<sup>th</sup> EDAC meeting. It will likely be a new collection that happens around the same time frame of Student October. Even when opting in to free lunch for all, EDAC thinks districts will still collect free and reduced lunch data since it ties into transportation, athletics, and other fees. CDE feels like there haven't been enough discussions across the board to implement a new indicator that can replace free and reduced lunch. Districts do not want to do another data collection where they would have to look up each student individually for SES ratio data. Not every address is going to have a response for the survey. The problem is the legislation says this needs to be done for 2023-2024. CDE hopes to find other options for 2023-2024 that are less burdensome on districts.

**Overview:**

The Student Interchange is required for state and federal reporting and consists of the Student Demographic, Student School Association, Graduation Guidelines, and the Adjustment files. Data in the Student Interchange is used for the determination of per pupil revenue funding, per C.R.S. 22-54-104, for the calculation and reporting of data in school accountability performance reports, per C.R.S. 22-11-204, and for federal ED Facts reporting.

**Discussion:**

**Do misreported graduates happen often? Very few per year.**

**Exit Code 90 - Graduated with regular diploma language is from ED Facts, so it was kept the same to match Federal naming on this data field.**

**Can funding code 84 under the School Association file be red lined? This was included in the approval.**

Legal name and correct spelling of districts, schools names and address's used in distribution of School Accountability Reports and other CDE/State Reports. Districts should complete the Directory information in order to supply the United States Department of Education and Colorado Department of Education with the correct pertinent information associated with their district and schools.

20 Minutes	<b>STP-101 ESSER Rural Coaction Request for Applications</b>	Matt Koziol
<p><b>Overview:</b>  The ESSER Rural Coaction grant was issued to 17 grantees between September 2022 and January 2023. This is a competitive grant funded through ARP ESSER 10% of state set-aside funds. Grantees signed assurances that they would submit end-of-year data on or before May 31 for each year in which as a requirement of being awarded the grant.</p>		
<p><b>Discussion: This is just for the 17 awardees, correct? Yes. It feels like we just did this with another ESSER collection, is this going to be similar - are you asking for the SASIDS so you can criteria for this specific group? Yes. Is this adding to the existing collection? There is an end of year program collection through Qualtrics that does not include PII. Since this includes PII, CDE is setting up Syncplicity to submit this portion that includes PII. Could this be done through pipeline? CDE was told that given the timeline it was not possible, but since it is for May 2024, this could be done through pipeline.</b></p>

20 Minutes	<b>NU-165 Summer Food Service Program Technology Mini-Grant (New)</b>	Mandy Christensen
<p><b>Overview:</b>  The purpose of this grant program is to provide funding to program sponsors to implement strategies to improve access to quality meals in the summer, increase accuracy of meal claiming, remove barriers to using the Mobile Meal Counter, and improve access to federal child nutrition programs. This funding opportunity will offer eligible sponsors the technology necessary to utilize the Summer Food Service Program (SFSP) Mobile Meal Counter Application. The Mobile Meal Counter provides greater accuracy in counting and claiming of school meals and makes it possible to expand the Summer Food Service Program and reach more youth in need of meals during the summer months.</p>		
<p><b>Discussion: Did CDE Build the Mobile Meal Counter App? Are we just paying someone to use another companies app? It seems strange that this is the case. Isn't this already tracked through a point-of-sale system? Main concern is that districts do not have to pay for this app since districts now have to report any paid apps that they are now implementing.</b></p>
